## GENERAL ANNOUNCEMENT

The Company hereby announces that Moody’s Investor Service has raised its corporate family rating on the Company and on its senior secured notes due 2027 to “B2” from “B3” and changed the outlook to positive from stable. This achievement reflects the Company’s robust operating and financial performance in 2023, exceeding initial forecasts and Moody’s expectation that this trend will continue.
